



AN OPEN APPEAL TO THE SUPREME COUNCILS OF PAS BERSATU AND UMNO.

A CALL FOR STRATEGIC REFLECTION — DO NOT BE MISLED BY ANWAR'S GREATEST POLITICAL DECEPTION

The Supreme Councils of PAS, BERSATU AND UMNO must confront an uncomfortable but unavoidable reality: the present escalation of race- and religion-based controversies is a strategically calculated political diversion, designed to shield the Prime Minister from a rapidly intensifying crisis of constitutional legitimacy.

The sudden, aggressive revival of the Hindu temple issue and the false and malicious terming of “Kuil Haram” and the politicisation of the pig farming industry in the last 1 month — two matters known to cause deep anxiety and distrust among Malay Muslims and Chinese and Indians — is neither coincidental nor rooted in genuine governance reform. These issues have existed for decades. What is unprecedented is the timing, coordination, and amplification of the narrative.

Above that Anwar Ibrahim has falsely and maliciously insinuated that I am an extremist (pelampau) that make unreasonable demands for Hindu temples and that Hindus were murdered in custody thus creating fear among Malay political parties that they may be dealing with an “enemy of Islam”.

The question that must be asked is simple and direct: **why now?**

THE REAL CRISIS: CONSTITUTIONAL LEGITIMACY

The answer lies in the growing pressure surrounding **Anwar Ibrahim**, pressure that no longer comes only from political rivals but also from **within the nation's constitutional framework**.

It is now widely acknowledged within political, legal, and institutional circles that formal complaints and detailed representations by eminent and credible persons have been submitted to the Palace and to the nine Malay Rulers, raising grave constitutional concerns regarding:

1. **Anwar Ibrahim's legitimacy to continue holding the office of Prime Minister**, including questions of his constitutional eligibility, moral authority, and the legal circumstances surrounding his appointment; and
2. **Anwar Ibrahim's unilateral execution of an agreement with the U.S. President, Donald Trump**, undertaken without adherence to constitutional requirements governing matters of national interest, thereby bypassing the constitutional authority, consultative, supervisory and legislative roles of the Yang di-Pertuan Agong, the Conference of Rulers, and Parliament.
3. **The resulting and very real risk of a serious erosion of the dignity, standing, and effective constitutional authority of the Royal Institution and the role of the 9 Malay Rulers**, arising from Anwar Ibrahim's actions of such magnitude which, if left unchecked or unaddressed, may amount in substance to a usurpation of powers and responsibilities expressly vested in the Yang di-Pertuan Agong and the Malay Rulers under the Federal Constitution, thereby undermining the

spirit, structure, and intended supremacy of constitutional monarchy and Parliamentary democracy in Malaysia.

More significantly, there are growing indications that **the Palace itself may now be confronting the Prime Minister** on these matters. This elevates the situation beyond ordinary political disagreement into the realm of a **constitutional and institutional crisis**.

THE LEGITIMACY CRISIS SURROUNDING ANWAR'S APPOINTMENT AND FITNESS TO GOVERN

Simultaneously, the Prime Minister's **appointment following GE15** is increasingly being challenged in court and in public discourse. Allegations have surfaced that the previous Yang di-Pertuan Agong may have been **misled regarding Anwar Ibrahim's eligibility and fitness to hold office**, particularly in light of unresolved legal disqualifications and the absence of a free pardon under Article 48.

Compounding this are further allegations now circulating in the public domain — including claims related to the framing of Yusuf Rawther in cases involving drugs which may carry death penalty and fake firearms, unresolved questions regarding alleged land cession to Indonesia in Sabah and the false narrative of “no mans’ land”, including separately the AMBALAT issue, that have not been openly debated in Parliament, and emerging narratives involving foreign interference in Malaysia’s affairs by the possibility of illegitimate influence upon Anwar Ibrahim linked to U.S. DOJ materials on Epstein. Together, these issues erode not only political credibility but **moral authority**.

This is the real crisis facing the nation — and these are the very issues Anwar is seeking to bury by engineering a false and divisive religious narrative, deliberately stoking artificial tensions as a strategic smokescreen to shield himself from the growing and unavoidable scrutiny of his leadership and constitutional legitimacy.

WHY RACE AND RELIGION ARE BEING WEAPONISED BY ANWAR

Instead, the nation is being deliberately redirected toward emotionally explosive issues — pork/pig farming and Hindu temples.

The Hindu temple issue is not a challenge to Malay rights or Islam. It is the consequence of historical policy failures, particularly following the mass enforced displacement of plantation communities totalling 800,000 in the 1980s and the subsequent conversion and privatisation of estate land. Many temples predate independence, yet their legal status was never resolved by successive governments hence creating a legal situation where these temples are sitting on private or government land .

Pig farming, likewise, has existed since before Merdeka, including in areas such as Tanjung Sepat. These are regulatory issues — not existential threats.

The repackaging of these sensitive matters by Anwar Ibrahim as symbols of Malay dispossession and Islamic endangerment is deliberate. It serves a singular political purpose: **to reconstruct the Prime Minister’s image as a defender of Malay-Muslim interests at a moment when his legitimacy is under siege and at its lowest support from the rakyat.**

A DIRECT THREAT TO PAS, BERSATU AND UMNO

PAS, BERSATU and UMNO must understand this clearly:

You are being drawn into a narrative that intentionally diverts attention from safeguarding the Royal Institution, Malay dignity, constitutional supremacy, Malaysia’s sovereignty and national stability.

Greater national interest calls for firm stand in defending these principles and resist attempts that serve only the Prime Minister's **political survival and long-term consolidation of power ahead of GE16**.

Every time you:

- Echo the framing of Hindu temples as inherently "illegal" without context;
- Amplify outrage over pig farming while ignoring constitutional breaches;
- Remain silent on the usurpation of powers specifically conferred to the Royal Institution, Parliament, and sovereignty;

You are **strengthening Anwar's strategy**, not weakening it.

This strategy is simple and ruthless:

- Chinese support is assumed to remain intact with DAP being part of PH.
- Indian support will be managed through fear of political alternatives from PN especially PAS.
- The sole remaining prize is the **Malay-Muslim vote bank**, to be fractured away from PAS, BERSATU and UMNO by the false manufacturing religious anxiety.

If you fall for this, you will not merely lose your traditional Malay vote bank — you will **legitimise the greatest political deception** that undermines constitutional governance.

THE DUTY OF THE CIVIL SERVICE AS THE FINAL INSTITUTIONAL GUARD

This appeal also extends to the **Attorney General, the Chief Secretary to the Government and top government officers**.

The doctrine of neutrality does not oblige civil servants to **facilitate or remain silent in the face of constitutional violations**. Loyalty is owed to the Constitution, the Yang di-Pertuan Agong, the Malay Rulers, and Parliament — not to Anwar Ibrahim.

Where there is credible evidence of unconstitutional conduct, erosion of parliamentary democracy, or usurpation of powers of Royal Institution, it is the **constitutional duty of senior civil servants to advise, document, and, where necessary, alert the Palace through lawful channels**.

Silence in such circumstances is not neutrality. It is **institutional failure**.

CONCLUSION: A MOMENT OF CHOICE

PAS, BERSATU and UMNO stand at a defining crossroads.

You may either:

- **Confront the real crisis** — constitutional legitimacy of Anwar Ibrahim and his unilateral decisions, stop erosion of powers bestowed to Yang Dipertuan Agong and the Malay Rulers, and role of Parliament as the highest authority in our Parliamentary democracy, as well as national sovereignty; or
- Allow yourselves to be **manipulated into fighting manufactured and artificial communal battles** that shield a beleaguered Prime Minister from accountability.

History will not judge intentions — it will judge outcomes.

Do not allow history to judge that you were victims of Anwar Ibrahim's greatest political deception of this era, when the Constitution was imperilled, and the authority and dignity of the Royal Institution were at stake and Parliamentary democracy tainted.
